- The data will be used by the organisers and co-financers and their respective subcontractors for this event exclusively for the purposes of content and logistical preparation, implementation and follow-up of the Regional Forum for Practitioners in Small Island Developing States on Advancing NDC Implementation Readiness, i.e. in particular for communication with the participants, and for booking flights, travel health insurance and in some cases hotels, and to support participants in applying for visas, and for further information exchange with among GIZ and their respective subcontractors for this specific event. Any other use is always subject to renewed consent. Your data will not be used for advertising purposes.
- The legal basis for processing your data is your consent to this declaration and the
 processing is necessary for the performance of a task carried out in the public
 interest or in the exercise of official authority vested in the controller (see Art. 6 lit.1
 (a) and (e) GDPR).



- The copyright of video and photo recordings made during the event is hold by GIZ.
 Video and photo recordings may be used in connection with the event and in general
 for the public relations work (e.g. brochure, website) of the co-organisers. The
 recordings will not be used commercially.
- GIZ protects the data by suitable technical and organisational measures against
 unintentional or intentional falsification, destruction, loss or access by unauthorised
 persons. Access to personal data is restricted to those employees of GIZ and
 subcontractors who have to process this data in accordance with the abovementioned purposes and handle it properly and confidentially.
- GIZ is entitled to forward personal data to their subcontractors for this event for the purpose of organising the event and logistics (e.g. booking flights) and coordinating with relevant service providers (e.g. shuttle service, hotel).
- The participation list with name, organisation affiliation and email address will be made available to the other participants.
- Cookies are small text files that are stored locally in the cache of the visitor's Internet browser, which we use for the duration of a session, and which serve to identify the user during login, select the correct menu language and ensure smooth operation.

Public rights concerning data storage and processing
